Newfield Public Library's "Afterschool Special"

2024/2025



The Afterschool Special is a fun, educational, enrichment program for middle school age students (grade 6-8/age 11-13). It takes place at the Newfield Public Library (NPL) on Main Street in Newfield. Students are invited to come to the library and participate in one of our scheduled activities or find a quiet space to use of our high-speed Wi-Fi and computers, work on homework, or play a board game!

This FREE program is every Tuesday, Wednesday, and Thursday from 3:30 - 4:20 pm starting October 15 and ends May 29, 2025. The program will be offered when Newfield Central School (NCS) is in session. There will be no program on NCS "early release" days, when NCS afterschool activities are cancelled, or when NCS or NPL is closed.

This program is made possible by a grant from the Bernard Carl and Shirley Rosen Library Fund of the Community Foundation of Tompkins County.

Afterschool Special Details

All participants are expected to arrive at the library by 3:30 pm and will be supervised upon arrival. NCS students can walk independently from the school to the library and are able to access the free school bus transportation back to the school at 4:20 pm then board the late bus. Students arriving past 3:30 pm will not be allowed to board the bus.

Participants are welcome to stay at the library unsupervised after 4:20 pm if they wish to work on homework or access resources available at the library, but pick up and transportation arrangements need to be made ahead of time between the participant and their family.

A snack will be provided free of charge to all participants and all scheduled activities will take place at the library or the Newfield History and Activity Center next door to the library.

Participants are not required to attend the program every day; they can attend when it is convenient for them. The Afterschool Special's weekly theme will be posted at the library and announced during the NCS morning announcements each Monday to help participants decide if they wish to attend that week.

Participants are expected to adhere to the library's Code of Conduct and exhibit respect and appropriate behavior at all times.
